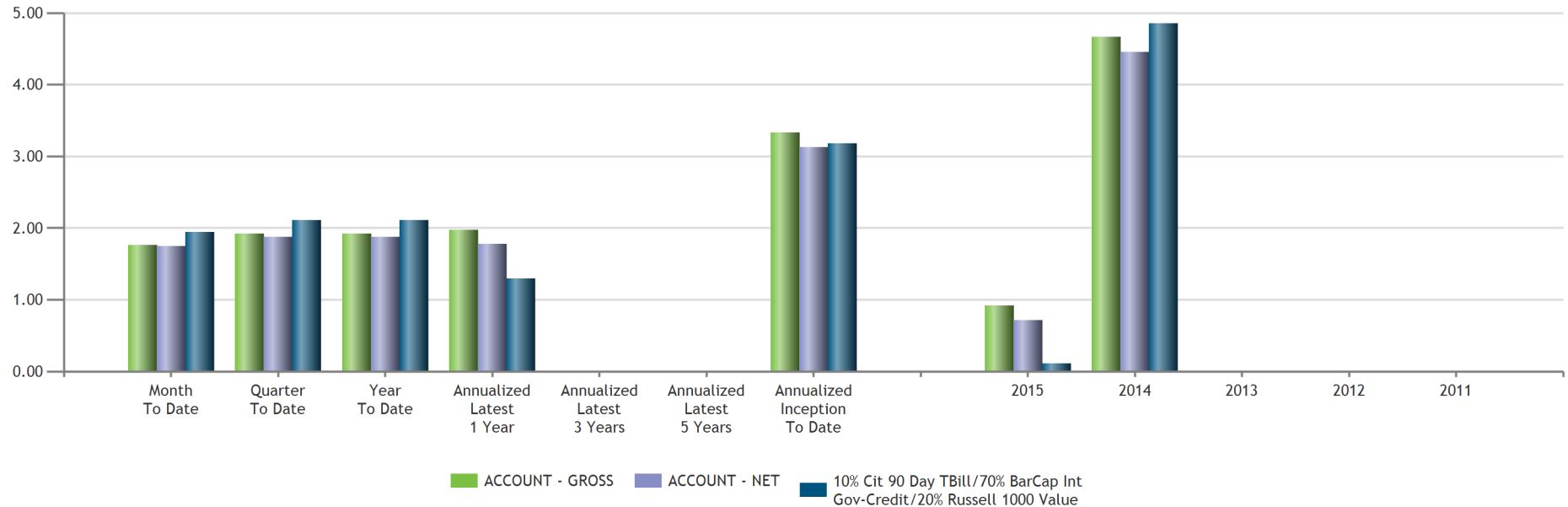

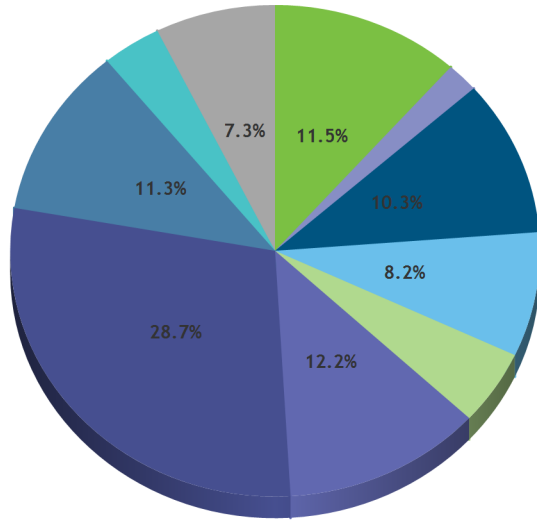

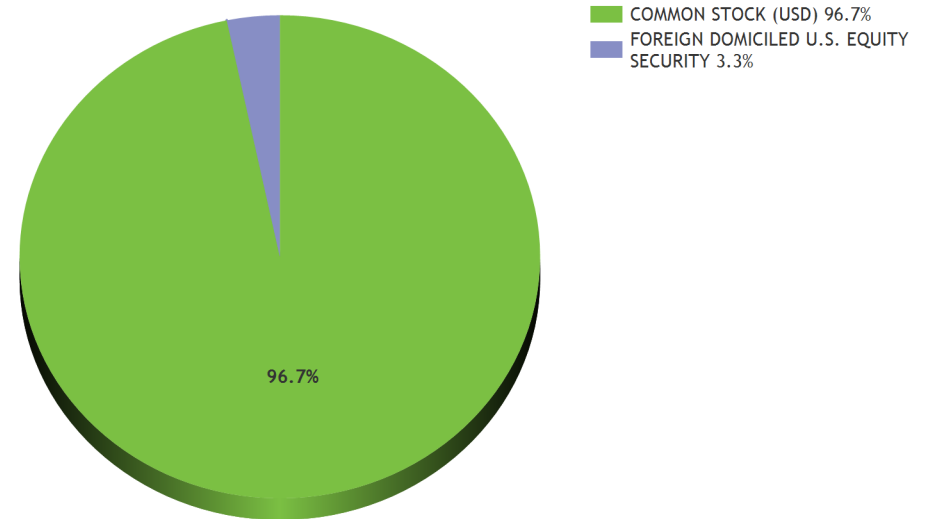

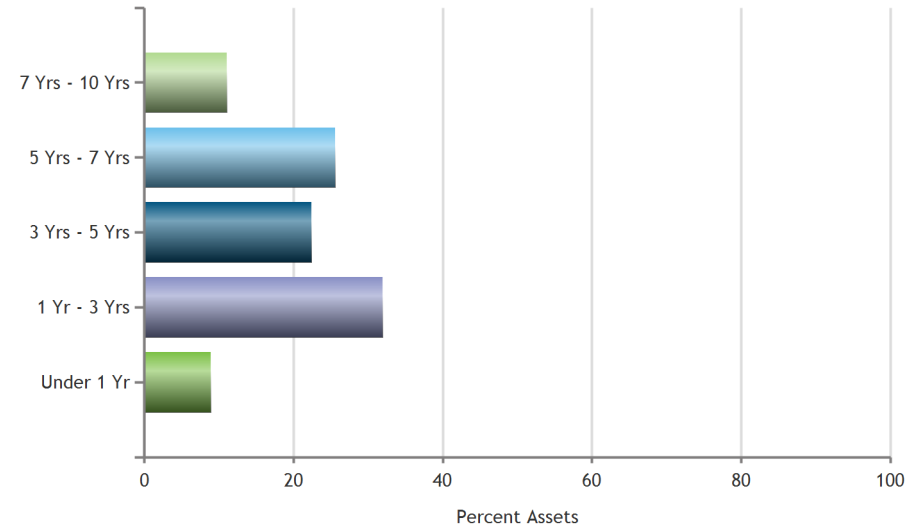
Equity Allocation by Security Type
